Owner will assume full financial/moral responsibility for the actions of their dog/cat(s). Owner acknowledges that dog/cat(s) will be exposed to other animals.
- 3) Owner acknowledges that the pet may be isolated and kept apart from other animals, should The Animal Den Pet Resort & Spa in its reasonable belief or the reasonable belief of its employees, determine that the animal may be in danger or may endanger other animals by virtue of its conduct, behavior or aggressive propensities. Owner understands that The Animal Den Pet Resort & Spa desires to maintain the health, reasonable care and comfort of all animals in our care.

POLICIES/TERMS

1. All pets must enter clean, free of fleas and parasites, with skin and coat in good condition. Since we strive to keep a clean environment a grooming charge may apply if we feel your pet requires such services.
2. All pets being boarded or groomed must be current on vaccinations and Vet office proof of vaccinations required. Proof of current Rabies, Bordetella and DHPP vaccination also required for dogs. FVRCP and Rabies for cats.
3. Dogs/Cats must be in good health and not have been ill with any communicable diseases within the last 30 days.
4. Medication must come dispensed in **original** containers with clear instructions. We do not accept pills/supplements placed in zip lock bags or out of the original prescribed bottle.
5. Pets' food must come **in zip-locked bags and pre-portioned for EACH meal**. We apologize but we do not have space for large bags of food/containers/scoops. Any food not packaged per our policy will be assessed a special handling fee. We can provide your pet with our HOUSE food, but there is an additional charge.
6. We provide blankets for each dog's comfort, however you may bring their own bedding from home, as long as it is machine washable and can fit in our washers.
7. When you sign the Guest Registration form you are consenting to emergency medical care in the event your pet(s) become seriously ill. We will make every attempt to contact you at the phone numbers you provide us. We will contact your vet first or take to emergency if needed.
8. Special handling fees apply for senior pets, medication administration, or aggressive pets. Please inquire if your pet fits that description.
9. The Animal Den Pet Resort & Spa is not responsible for the loss of toys, bedding, or blankets that are not clearly labeled with the pet's name.
10. Check out time is 12:00 pm. If your pet is not picked up by check out, Day Care charges will be added to your bill.
11. Groom dogs must be picked up by 12pm, or Day Care charges will be billed
12. Resort hours are posted for your convenience. Before/After hour pick up can be arranged for a charge of \$50. A 72 hour notice required.
13. Because we have limited space and a waiting list, a 48 hour cancellation for weekdays and a 72 hour cancellation on weekends/holidays is required on your reservations. Any reservation not cancelled per our policy will be billed to the guest.
14. Your dog will be evaluated for group play sessions. We reserve the right to refuse group play time for any pet that possess a threat to a staff member or other boarder. Please inform us if you chose to not have your pet participate in group play sessions.
15. Fees for boarding/grooming and other services are due and payable when your pet is released. We do not allow partial payment or billing. The pet will only be released to the owner unless arrangements have been made in advance. Up front payment is required for pets staying longer than 30 days. If your pet is left longer than 30days without payment, you voluntarily relinquish rights of ownership.
16. Our doors are locked and not open to the public on: Easter, Thanksgiving, Christmas, New Years Day, July 4th, Memorial Day, and Labor Day. **If your pet is here during one of the above holidays, an extra nights' stay is added to your bill.**
17. Owner agrees that The Animal Den Pet Resort & Spa shall not be liable for any loss or damage to the animal by any cause whatsoever, including fire, theft, and escape of animal. Owner assumes and understands that the pet is in an environment where other pets can be located together in a social atmosphere and the facility is not liable for the damaged caused by or from another animal.
18. The Animal Den Pet Resort & Spa will not knowingly accept dogs into our play sessions that have not been spayed/neutered.
19. The Animal Den Pet Resort reserves the right to decline future reservations for pets that are overly aggressive, display excessive barking habits, or show signs of stress.
20. Checks returned NSF will be billed \$25/check + original payment due.
